- I. Discharge appeal hearing of DPS employee Tywan Shelton. Tywan Shelton appeared before the Commission to appeal his discharge. He was not represented by counsel. DPS was represented by Phillip Adkins of the General Counsel's Office. Court reporter was Shana Wise of Esquire Deposition Services. Opening statements were made by Mr. Adkins and Mr. Shelton. All witnesses were sworn. Sergeant William David Warren; Driver License Division, was the only DPS witness. DPS Exhibit #1 was submitted and accepted by the Commission. The only appellant witness was Tywan Shelton. Appellant Exhibit #1 was submitted and accepted by the Commission. Closing statements were made by Mr. Adkins and Mr. Shelton.
- Personnel Matters. The Commission went into Executive Session pursuant to Tex. Gov. Code Sec. 551.074 to discuss the discharge appeal hearing of DPS employee Tywan Shelton. Upon reconvening Regular Session, a motion was made by Commissioner Angelo, seconded by Commissioner Cascos and unanimously passed affirming the Director's discharge of Tywan Shelton (see attached Order).
