Public Safety Commission Meeting Agenda - Other Victim Assistance Grant

The Infrastructure Operations Division placed a consent item on the agenda for the Public Safety Commission (PSC) meeting scheduled for April 10, 2025 regarding the renewal application for the Other Victim Assistance Grant (OVAG). The grant application requires a member of the PSC to initial next to the grant program (the Other Victim Assistance Grant (OVAG)) the DPS Victim and Employee Support Services (VESS) is applying for and sign the Resolution of Governing Body, which will designate Colonel Martin as the Authorized Official for the grant.

The OVAG grant is competitive funding through the Office of the Attorney General. The DPS VESS applies each biennium and has been continuously awarded this funding since FY 2006.

For fiscal years 2026 and 2027, the grant application requests up to \$150,000 per year for 50% funding of the personnel costs for four VESS positions. The funded positions primarily serve victims of crime, disaster, and traumatic events by providing mandated victim assistance, counseling, advocacy, and other support services statewide.

The positions are in Central, West, South, and Southeast Texas Regions.
