Director McCraw provided an update on legislative testimony and briefings that can be found under the Government Relations division report.

- C. Operation Strong Safety (0:52:50)
- -Tasked by Speaker's Office to meet and brief every chair in the House on border security all offices have been contacted
- -On June 18, 2014, Governor/ Lieutenant Governor/Speaker issued a DPS directive to conduct a multi-agency surge operation in the Rio Grande Valley due to an influx of unaccompanied children and prevent continued smuggling between the Ports of Entry
- -Surge operations began on 6/23/14 (5 days from date directive was issued)
- -Authorization given to spend \$1.3 million per week for operations
- -25% reduction in undocumented aliens crossing into Hidalgo and Starr Counties during the second week

A motion was made by Commissioner Flores seconded by Commissioner Watson authorizing the director to make conforming changes as we move forward in the process as directed by the LBB to the LAR and El process. Any changes will be presented to the Public Safety Commission as redline. Motion passed unanimously.

B. Report, discussion, and possible action on SUV Patrol Fleet (1:28:12)

AD Luis Gonzalez and Major William Diggs provided a brief on Dodge Chargers vs

Chevrolet Tahoes

- -Study conducted by University at Buffalo's Center for Transportation Injury Research:
 - *Risk of death is 24 times greater in a passenger car than SUV
- *Head-on crashes are 7.6 times greater in a passenger car than SUV (higher and heavier is safer)
- -National Center for Statistics and Analysis-National Highway Traffic Safety Administration (June 2011):

- *Fatal first-event rollovers were reduced by 56% in cars and 74% in light trucks and vans (LTVs)
- *Fatal impacts with fixed subjects were reduced by 47% in cars and 45% in LTVs
- -Cost comparison: Chevy Tahoe purchase cost per mile \$.3526 cents @ 110,000 miles / Dodge Charger purchase cost per mile \$.3531 cents @ 90,000 miles
- -Current THP fleet is 1,548 patrol sedans and 668 patrol Tahoe's
- -Since 2000, DPS has lost 11 troopers in the line of duty, 8 involved in traffic crashes while operating a patrol car sedan

Commissioner Watson would like to see more hands-free features for troopers in their vehicles.

- -FirstNet created in February 2012 \$7 billion reserved for build out of network nationwide (commercial carriers use \$80 billion to build their networks)
- -First operational PSLTE System in the world was built in Harris County
- -Texas is 1 of 5 early-builder jurisdictions moving forward (Texas, New Mexico, New Jersey, Colorado, and California)
- -Spectrum Manager Lease Agreement (93 total sites in Harris County / 1 site Kyle Field / 1 mobile site)

These amendments are intended to eliminate unnecessary rule-based definitions of terms defined elsewhere in statute. In particular, the 83rd Texas Legislature's amendments to Chapter 481 of the Health and Safety Code through Senate Bill 1643 created a statutory definition of "freestanding emergency clinic," thus rendering the rule-based definition redundant.

The Texas Department of Public Safety (the department) adopts the proposed amendments to Sections 13.71, 13.72, and 13.82, concerning Texas Prescription Program. Section 13.71 and Section 13.72 are adopted without changes to the proposed text as published in the July 4, 2014 issue of the *Texas Register* (39 TexReg 5126) and will not be republished. Section 13.82 is adopted with changes to the proposed text and will be republished.

These amendments are intended to assist with implementation of the 83rd Texas Legislature's amendments to Chapter 481 of the Health and Safety Code through House Bill 1803, Senate Bill 406, and Senate Bill 1643. Respectively, these bills affect the process by which physicians may renew their controlled substance registrations; the delegation of prescriptive authority by physicians to advanced practice registered nurses or physician assistant; and the delegation of authority to access the DPS prescription database by practitioners or pharmacists to nurses or pharmacy technicians.

The department received comments from Ms. Mary Staples, on behalf of the National Association of Chain Drug Stores, and Mr. Doug Ream, on behalf of H-E-B Pharmacy. Both asked that the proposed number of pharmacy technicians to whom a pharmacist may delegate the authority to access the department's prescription drug database be increased from three to four. The department agrees with this suggestion and has amended the proposal accordingly.

Additional comments were made by Ms. Staples and Mr. Ream relating to the desirability of an online process for the delegation or rescission of authority to access the DPS prescription database by practitioners or pharmacists to nurses or pharmacy technicians. The department agrees that such an online process is desirable and is working to develop the necessary software interface. The rules will be amended in the future, upon development of the online process.

Mr. Ream asked that the department clarify proposed Section 13.82(f)'s reference to "administrative action against the registration of the delegating ... pharmacist," as registrations are held by pharmacies rather than pharmacists. The department agrees that clarification is necessary and has amended the proposal to refer generally to the "responsible registrant."

Mr. Ream also asked that the department amend Section 13.72(a)(1) to permit advanced practice registered nurses or physician assistants to submit electronic prescriptions. The department agrees with the comment and is working to develop the necessary software interface. The rules will be amended in the future, upon development of the online process.

Both parties offered proposals relating to matters of policy or legislative action which do not relate to the rule proposals. The department will address these issues with Ms. Staples and Mr. Ream directly.

Section 15.82 and Section 15.83 provide that upon notification of the department's determination of suspension, disqualification or revocation, a licensee may request a hearing. Section 15.84 prescribes specific procedures for a requested hearing.

These amendments are necessary to incorporate new moving violations that result in a driver being assigned points under the Driver Responsibility Program, as defined by Texas Transportation Code, Section 708.052. Texas Code of Criminal Procedure, §102.022 requires Texas state and local courts to assess a fine of ten cents for any moving violation conviction as defined by Texas Transportation Code, Section 708.052. Section 15.89 was originally adopted June 22, 2004 to provide a definition of a moving violation. This rule also integrated a list of moving violations assigned points under the Driver Responsibility Program.

No comments were received regarding the adoption of this proposal.
