The Public Safety Commission met in Austin, Texas on December 5, 2013. Attending the meeting were Chairman Cynthia Leon, Commissioners Carin Barth, Randy Watson and Steven Mach. A quorum was present at the meeting. DPS staff members and guests were also present.

# Call to Order (0:00:09)

The meeting was called to order by Chairman Leon at 9:02 a.m. Proper notice had been posted.

Chairman Leon introduced Steven Mach as the newest member of the Public Safety Commission. Commissioner Mach is the Vice President and CFO of Mach Industrial Group in Houston.

# A.Recognition of service for Allan B. Polunsky – Former Commissioner and Chairman Texas Public Safety Commission

Former Commissioner Allan Polunsky was named an Honorary Texas Ranger Captain in recognition for his more than six years of service on the Public Safety Commission. A motion was made by Commissioner Mach seconded by Commissioner Watson approving the motion to name Allan Polunsky as an Honorary Texas Ranger Captain. Motion was passed unanimously.

## B.Presentations cont'd (0:28:00)

Enrique Lucero, ICE San Antonio, presented Assistant Director Tom Ruocco with the US Department of Homeland Security Law Enforcement Information Sharing Outstanding Achiever Award and Director McCraw with the US Immigration and Customs Enforcement Director's Service to the Homeland Award.

# C.Impact Texas Teen Drivers Program (0:32:13)

- -In May 2009, DPS lost the authority to delegate authority for the skills tests for driving
- -Chairman Larry Phillips, House Transportation Committee, is concerned with the rising number of teen deaths
- -SB 1705 (approved this last session) DPS regained authority and incorporates training into driving schools (driving schools can now issue driving tests)
- -To implement SB 1705, TEA will incorporate a 1 ½ hour distracted driving training to the curriculum
- -Texas will use the California model (Impact Teen Drivers Program), which was introduced at the International Association of Chiefs of Police conference, and modify the curriculum for Texas (Impact Texas Teen Drivers Program)

## **New Business** (0:45:25)

A.Report, discussion, and possible action on proposed amendments to Professional Conduct Rule for publication to receive public comment

Director McCraw is seeking approval to post Professional Conduct Rule for publication. A motion was made by Commissioner Barth seconded by Commissioner Mach approving revision of the Ten General Orders to receive public comment. Motion passed unanimously.

## B.Report and discussion regarding the contracting policies (0:48:08)

AD Arriaga provided an update on the improvement of contracting polices.

- -Front end review by Contract Review Board
- -Weekly updates and constant monitoring
- -As of November 18, 2013, 53 requested contracts reviewed in FY 14 (\$65.8M)

# C.Report, discussion and possible action on Equal Employment Opportunity compliance/refresher training (0:58:42)

DAD Nathanael Haddox provided an EEO annual update:

- -8,572 permanent employees have taken training
- -607 employees must complete training by 12/31/13
- 2013 Allegations and Investigations (January 2013 November 15, 2013):
- -172 allegations reported (18 still under investigation)
- -63 sustained (2 discrimination/2 sexual harassment/1 harassment/53 unprofessional conduct/4 failure to report/1 retaliation)
- -Investigation timeline is 31 34 days

The Commission adjourned for a small break at 10:08 a.m. before continuing with the agenda. The Commission reconvened at 10:17 a.m.

# D.Report and discussion regarding Texas Anti-Gang Center (1:06:50)

Regional Commander Duane Steen reported on the Texas Anti-Gang Center located in Houston:

- -Operational since April 2013
- -Governor's Criminal Justice Division awarded a grant for \$1,699,520
- -Grant executor is the Harris County District Attorney's Office
- -Participating agencies: DPS, FBI, DEA, ATF, ICE, Houston Police Department, Harris County Sheriff's Office, TDCJ-OIG and the Texas National Guard 2013 Stats (January 2013 October 2013):
- -448 investigations opened
- -352 arrests
- -229 high risk arrests
- -144 weapons seized
- -\$3,592,000 property seized
- -\$5,500,000 drugs seized

# E.Report and discussion on mounted patrols at Capitol (1:23:04)

Regional Commander Joe Ortiz provided a brief on mounted patrols:

-Currently have 2 – Trooper and Ranger – who are a 4 and 5 year old gelding horses in training

- -Both were donated by an organization in Houston and the trailer was seized property
- -Utilizing the Parelli training method used by Houston and City of Austin
- -Trooper and Ranger are scheduled to be released to patrol in December or January
- -Austin Police Department has 88 acres of land and will be getting a new 24-stall facility and they have offered DPS 6 stalls at a cost of \$1.00 per year.

## F.Report and discussion regarding the DPS Physical Fitness Program (1:34:58)

Lieutenant Greg Davis provided an update on the Physical Fitness Program:

-Started in March 2010

- -Commissioned PRT Percentages 498 individuals 494 passed, 4 failed
- -Commissioned VO2 Percentages 7,349 individuals 7,227 passed, 122 failed
- -Combat Fitness 427 individuals 425 passed, 2 failed

**DPS Capitol Fitness Initiative:** 

- -17 state agencies participating
- -306 participants

# G.Report, discussion and possible action on administrative rule posting and adoption process (1:56:08)

General Counsel Adkins presented a proposed modification of the manner in which the Commission adopts administrative rules. Currently, staff presents proposed rules to the commission twice. First, rules are presented to the Commission for the purpose of approving the publication of a proposed rule in the Texas Register to receive public comment. Second, after rules have been published and commented upon, the rules are brought back before the commission for consideration and adoption. GC Adkins proposed that on procedural or "housekeeping" type rules the Commission grant staff authority to publish and seek comment before presenting the rules to the Commission. After receiving comment, the rules and any comments received would be presented to the Commission for potential action adopting the rule.

The commission discussed the proposal. Commissioner Mach suggested that the proposal be modified to use a rules liaison from the commission who would be given notice of the staff's intent to publish rules for comment prior to commission approval.

A motion was made by Commission Mach and seconded by Commissioner Barth that the modified rules adoption process be adopted with the specific requirement that staff inform the commission rules liaison of occasions in which staff seeks to publish a rule for comment prior to commission action. The Motion passed unanimously. Chairman Leon will serve as the commission rules liaison.
