**PUBLIC SAFETY COMMISSION**  
**April 14, 2016**  
**AUSTIN, TX**

The Public Safety Commission met in Austin, Texas on April 14, 2016. Attending the meeting were Chairman Cynthia Leon, Commissioners Faith Johnson, Manny Flores, Steven Mach and Randy Watson. A quorum was present at the meeting. DPS staff members and guests were also present.

**CALL TO ORDER** (0:00:05)

The meeting was called to order by Chairman Leon at 9:02 a.m. Proper notice had been posted.

**APPROVAL OF MINUTES** (0:00:43)

**A motion was made by Commissioner Mach, seconded by Commissioner Johnson, approving the minutes from the February 10<sup>th</sup> and 11<sup>th</sup>, 2016 meetings. Motion passed unanimously.**

**PUBLIC COMMENT** (0:01:08)

-Robert R. Shea, current student at the LBJ School of Public Affairs – open and campus carry curriculum recommendations:

- \*Additional training needed on risk and characteristics of suicide and domestic violence
- \*Suicides are responsible for 2/3 of the firearms deaths – elderly are high risk for suicide

-Andrea Brauer, Executive Director, Texas Gun Sense – increase awareness for gun Safety

- \*2,800 gun deaths per year (60% are suicides)
- \*April is Child Abuse and Neglect Prevention Month
- \*67% of child homicides involve a weapon
- \*37% of youth suicides involve a weapon or firearm
- \*Seeking assistance from DPS to add gun safety education on our website
- \*Invitation extended to attend their next quarterly Coalition to Reduce Gun Violence meeting in Austin on June 2<sup>nd</sup> at the Capitol

-Dr. Cheasty Anderson, Senior Policy Analyst, Childrens Defense Funding of Texas – gun safety awareness

- \*Increase in the number of homicides, suicides and accidental deaths by having a gun

in the home are 3x higher for homicides, 3-5x higher for suicides, and 4x higher for accidental deaths

- Issue a statewide safe storage campaign for public awareness
- Legislation to add Active Shooter Training Program for school personnel
- Fund a Child Fatality Review Team Coordinator for each public health service region

## **DIRECTORS REPORT**

### **B. DPS Dashboard Revisions** (0:57:00)

Director McCraw reported on the updated DPS dashboard:

- Dashboard and the Border Security Briefing will be posted on our website by close of business Friday
- Presentation of the first case update involving a trooper, will continue to present a case at each Commission meeting

### **C. Case Update** (0:58:42)

- September 10, 2014, officer shooting case involving Trooper Jaime Galindo in Nolan County
- Routine patrol on US 84 near Roscoe, Texas
- Traffic stop initiated in which Brandon Joseph Cormier is discovered to have a warrant for a parole violation
- Cormier is advised he is under arrest and did not comply; shots fired
- Cormier was sentenced to 60 years confinement after entering a guilty plea to attempted capital murder of a peace officer
- In addition, Cormier was also given 10 years for the federal charge of unlawful possession of a firearm by a felon. He will serve at least 30 years for the attempted capital murder offense and 10 years day-for-day on the federal offense before he will be eligible for parole.

(1:16:44) Director McCraw introduced Steve Tidwell, Executive Director of the FBI National Academy. Mr. Tidwell praised the S.H.I.E.L.D. program and stated the Academy proudly endorses the program.

Sergeant Melvin Allick and Lacy Wolff provided a brief on S.H.I.E.L.D.:

- S.H.I.E.L.D. (Strength and Honor In Everyday Lawful Decisions)
- Mission is to assist law enforcement officers to effectively deal with on and off duty challenges
- Eight hour course taught in six of the seven regions
- Reached out to 90 federal, state and local agencies with over 1,000 attendees
- Program is broken down into five series: (1) Deals with the stress of the job; (2) How to deflect adverse conditions; (3) Performance under pressure; (4) Sleep cycle and the effect of stimulants on fatigue; and (5) Transition from work to home
- Family Program is currently being developed and will be introduced to the A-2016 class during Family Night

### **B. Report, discussion, and possible action on the FY 2017 Internal Operating Budget (1:38:02)**

- AD Suzy Whittenton introduced Gordon Taylor, Deputy Assistant Director, Budget
- FY 2017 total budget is lower due to decrease in federal funds; most of our budget is from General Revenue
- FTEs increased by 197 (officers on the border)
- 64% of the budget is in Salaries
- Capital Budget – IT Technology and Vehicles
- Exceptional Items will be presented at the June meeting

**A motion was made by Commissioner Flores, seconded by Commission Watson, approving the FY 2017 Internal Operating Budget. Motion passed unanimously.**

### **C. Report and discussion on the Equal Employment Opportunity Annual Report (1:46:01)**

DAD Nathanael Haddox provided an update on the 2015 EEO Annual Report:

- 99.8% are in compliance, as of 12/31/15, with this two year training
- Reporting Trends: 165 Complaints Filed and 53 Sustained (18.25)
- 2015 Intake and Investigation:
  - \*227 Allegations Reported
  - \*165 Investigations Completed
  - \*3 Allegations Open Under Investigation
  - \*53 Sustained (48 Unprofessional Conduct; 4 Failure to Report, and 1 Confidentiality)
  - \*16 Sustained Courtesy Policy Violation
  - \*155 No Violation of Section 18.25
- Investigation Timeline:
  - \*EEO Intake – 2 days

- \*Investigator Time – 16 days
- \*OGC Review Time – 6 days
- \*EEO Review Time – 1 day
- \*AD Review Time – 9 days
- \*Overall Investigation Time – 34 days

#### D. Report and discussion on DPS Vendor Initiative Program (1:59:03)

AD Amanda Arriaga and DAD Jessica Ballew provided a brief on the Vendor Initiative Program:

- Vendor Contact Policy discourages contact outside the formal procurement process
- Requestor must gain approval from the Procurement Director
- Requires vendor to certify the meeting is not part of competitive procurement process and no agency decisions will be based on interaction
- Ensures if a DAD or above has such interaction with a vendor, they must recuse themselves from future procurement with that vendor, product or service
- Methods of gathering information from vendors: (1) Request For Information; (2) discussions with peer agencies; and (3) conducting market research
- First Market Research Day is scheduled for April 18<sup>th</sup> (80 vendors) and will continue on a monthly basis. Topics to include: Social Media Investigation; Mobile App Platforms; Crowd Sourcing Software Development; Cloud Storage Solutions; Event-Driven Detection Capabilities; Artificial Intelligence Sensors; and Full-Motion Imagery Sensors

#### E. Staff Briefing on Impact Texas Teen Drivers Program (2:09:30)

AD Joe Peters provided a brief on the Impact Texas Teen Drivers Program:

- Two hour video course to educate new drivers on the impact of distracted driving (effective 9/1/15)
- Requirement for young drivers from 18 to 24 years of age
- As of the end of March 2016, there are 661,000 young drivers in Texas and since September 1, 2015, 16% (116,000) have completed this course
- Intent is to evaluate those who have completed training and compare their records to those who have not had training
- TxDOT has agreed to give DPS access to their crash data so we can run our own reports

DAD Wayne Mueller issued an explanation for approval on a Memorandum of Understanding (MOU) between DPS and the Texas Facilities Commission:

- MOU replaces the previous letter of agreement (DPS currently has about 300 leases/MOUs that fall into this delegation)

-Blanket approval from the Commission for overall designation and future delegation requests

-Types of lease agreements delegated:

\*Aircraft hangars

\*Boat storage

\*Office space from other political subdivisions or agencies

\*Surface leases for CDL testing

**A motion was made by Commissioner Mach, seconded by Commissioner Johnson, approving the Resolution for Delegation of Leasing Authority. Motion passed unanimously.**



**RESOLUTION BY THE PUBLIC SAFETY COMMISSION  
DELEGATED LEASING AUTHORITY**

The Texas Facilities Commission ("TFC") and the Texas Department of Public Safety ("TXDPS") have entered into a Memorandum of Agreement ("MOA") to delegate leasing authority for certain facilities from TFC to TXDPS. TFC's administrative rules require that a request by a state agency for delegated leasing authority must have the approval of the governing body of the agency making the request.

BE IT RESOLVED BY THE PUBLIC SAFETY COMMISSION:

1. That the MOA between TFC and TXDPS for delegated leasing authority is hereby approved.
2. That Steven C. McCraw, the Director of TXDPS, or his designee, is hereby authorized to make requests for delegated leasing authority not otherwise delegated in the MOA.

This resolution was considered and approved by a majority of the members of the Public Safety Commission of the State of Texas at its Open Meeting held on the 14<sup>th</sup> day of April, 2016, in Travis County, Texas.

**MEMORANDUM OF AGREEMENT FOR  
DELEGATED AUTHORITY BETWEEN THE  
TEXAS FACILITIES COMMISSION  
AND THE  
TEXAS DEPARTMENT OF PUBLIC SAFETY**

This Memorandum of Agreement ("MOA") is made and entered into by and between the **Texas Facilities Commission** ("TFC") and the **Texas Department of Public Safety** ("DPS"), both acting on behalf of the State of Texas by and through its duly authorized officials.

**WHEREAS**, TFC is the state agency with primary responsibility for leasing facilities for state agencies including DPS; and

**WHEREAS**, DPS has requested that TFC delegate authority to DPS to lease certain facilities on behalf of DPS; and

**WHEREAS**, TFC delegates authority to DPS to lease certain facilities on the specified terms and conditions as set out herein; and

**WHEREAS**, Title 1, Part 5, Subchapter A, Section 115.4, Texas Administrative Code, states:

A request by an agency for delegated leasing authority must have the approval of the governing body of the agency making the request. Any agency under the authority of an individual Commissioner or Executive Director, appointed by or directly accountable to the Governor, must provide evidence of notification to the Office of the Governor in order for such a request to be considered valid; and

**WHEREAS**, DPS has obtained the approval of its governing body, the Public Safety Commission ("PSC"), for this MOA, with a copy of the PSC's resolution approving this MOA attached and incorporated herein as Exhibit A ("Resolution"); and

**WHEREAS**, the PSC has delegated to the Director of DPS, or his designee, the authority to make requests for delegated leasing authority not otherwise delegated by this MOA, reference the Resolution delegating same; and

**WHEREAS**, the parties intend for this MOA to satisfy the requirements of Title 1, Part 5, Subchapter A, Section 115.4, Texas Administrative Code, without reoccurring action by DPS or the PSC;

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements contained herein, TFC and DPS hereby agree as follows:

1. Delegation of Authority. TFC delegates leasing authority to DPS for:
  - a. space needs during states of emergency as declared by the Office of the Governor;

- b. space provided by another governmental entity at or below fair market value as determined by DPS with notice as described in Section 6 to TFC. Any costs incurred will be the sole and full responsibility of the party who incurs same; and
- c. aircraft hangar space and boat storage space with private sources or for profit lessors and governmental entities.

2. Types of Space Authorized. The types of space that DPS may lease pursuant to this delegation of authority are:

- a. client services offices;
- b. administrative offices and related storage;
- c. warehouse;
- d. laboratory;
- e. vehicle parking areas;
- f. boat storage;
- g. aircraft storage; or
- h. any combination of the above.

DPS has authority to enter into radio antenna and tower communications leases, including leases of land for construction of a radio tower antenna tower, without a delegation from TFC, pursuant to Texas Government Code, Section 2167.001(b)(1).

3. Delegated Lease Requirements. For each delegated lease, DPS shall:

- a. define the gross square feet of leased space;
- b. define all costs for the leased space;
- c. perform best value analysis of proposed lease costs including confirmation that costs are lower than commercially available space in the general vicinity. A best value analysis is not required for no-cost or nominal-cost value leases;
- d. define start and end date of lease;
- e. include an early right to cancel, if possible; and

f. provide that emergency leases will not exceed 12 months.

4. Authorized Lessors. DPS is delegated authority to lease space from certain authorized lessors as follow:

- a. state agencies per Section 2167.051(1), Texas Government Code;
- b. federal agencies per Section 2167.051(2)(a), Texas Government Code;
- c. political subdivisions per Section 2167.051(2)(b), Texas Government Code; and
- d. Texas Retirement System per Section 2167.051(2)(c), Texas Government Code.

No private source or for profit lessors are permitted except for emergency leases, aircraft hangar space, and boat storage leases per Section 2167.052, Texas Government Code.

5. Administration. Upon execution of a lease for which DPS is delegated authority, and subject to the limitations stated elsewhere in this delegation, DPS is authorized to administer the lease to ensure prompt performances of all necessary actions and compliance with the terms and conditions of the lease, which will include but not be limited to the duties enumerated below:

- a. assume day-to-day management of the lease;
- b. monitor the lessor's performance to assure compliance with requirements of the lease;
- c. negotiate and execute within the scope of the lease, modification agreements, and supplemental lease agreements;
- d. review and approve technical reports, build-out plans, and other items required for approval, if any;
- e. routinely perform physical inspection and approve the lease space;
- f. verify availability of funding prior to obligating agency monies, if applicable;
- g. assure that changes in terms and conditions under the lease are not implemented before written authorization or a modification or supplemental lease agreement is issued;
- h. timely issue written notifications of intent to exercise extensions and/or renewal options of the lease;
- i. modify or amend the lease as necessary based on conditions and provide written notification to all appropriate parties;
- j. administer all escalations as provided for in the lease and coordinate payments with the appropriate office;

- k. enforce the lease according to its terms and provisions including direct notification to the lessor or his/her designated representative of any instance of failure to deliver services, maintenance or utilities in accordance with lessor's obligations under the lease;
- l. exercise authority to take corrective action for the lessor's failure to deliver services, maintenance, or utilities including authorizing rental deductions; and
- m. issue the final decision on disputes arising between the lessor and DPS in compliance with applicable law.

6. Reporting Requirements. All DPS leases acquired pursuant to this MOA must be submitted to TFC every six (6) months. DPS shall notify TFC in writing of any additions or removals to the biannual report within thirty (30) calendar days. DPS shall certify that all information provided in the reports is current and accurate. All biannual reports must include the following:

- a. DPS region;
- b. lessor name, street address, city, county and zip code;
- c. emergency or non-emergency status;
- d. DPS divisions located at or using the lease space;
- d. gross square footage;
- e. number of FTEs located at or using lease space;
- f. type of lease agreement including: (1) Inter-Governmental Contract/Inter-Agency Contract; (2) Memorandum of Understanding/Agreement; or (3) Letter of Agreement or other form of agreement;
- g. annual costs, if any, including: (1) rent; (2) custodial; (3) utilities; and (4) miscellaneous if fixed and reoccurring; and
- h. term including: (1) start date; (2) end date.

TFC reserves the right to audit DPS leases reported pursuant to this MOA upon reasonable notice to DPS.

7. Limitations. This delegation does not authorize DPS to take any other actions, including but not limited to the following:

- a. change the general terms and conditions of a lease that was originally delegated under Section 1 of this MOA in a manner that would change the character of the lease so that it was no longer delegated under Section 1 and therefore, outside the scope of the this MOA; or

b. re-delegate or otherwise assign or transfer the authority granted herein.

8. Entire Agreement. This MOA contains the entire understanding of TFC and DPS. This MOA supersedes all previous discussions, proposals, or agreements between TFC and DPS with respect to the subject matter of this MOA. This MOA may be amended only by mutual written agreement executed by both parties.

9. Termination. TFC may revoke delegated leasing authority upon written notice to DPS. Otherwise, this MOA will continue in full force and effect unless terminated by operation of law or by written agreement signed by authorized representatives of both parties.

RULE §115.4	Delegation of Authority to State Agencies

---

A request by an agency for delegated leasing authority must have the approval of the governing body of the agency making the request. Any agency under the authority of an individual Commissioner or Executive Director, appointed by or directly accountable to the Governor, must provide evidence of notification to the Office of the Governor in order for such a request to be considered valid. The Commission may revoke delegated leasing authority upon notice to the affected state entity.
