PUBLIC SAFETY COMMISSION
APRIL 17, 2013
AUSTIN, TX

The Public Safety Commission met in Austin, Texas on April 17, 2013. Attending the meeting were Chairman Cynthia Leon, Commissioners Ada Brown, Allan Polunsky and Randy Watson. Commissioner Carin Barth was not present at the time of roll call. A quorum was present at the meeting. DPS staff members and guests were also present.

Call to Order (0:00:01)

The meeting was called to order by Chairman Leon at 9:03 a.m. Proper notice had been posted.

Approval of Minutes (0:00:57)

A motion was made by Commissioner Brown seconded by Commissioner Polunsky approving the minutes as submitted for February 14 and 15, 2013. Motion passed unanimously.

Public Comment (0:01:41)

Hank Whitman – President, Texas Ranger Hall of Fame & Museum, informing the Public Safety Commission of its capital campaign for the bicentennial celebration of the Texas Ranger Hall of Fame & Museum to occur in less than 10 years. Byron Johnson, Director, provided a brief presentation regarding the Museum. Jack Dean and Co-Chair Ross Darden were also in attendance. Chairman Leon and Commissioner Watson voiced their support of the campaign.

Commissioner Brown thanked them for protecting the integrity of the DPS family.

Public Comment (1:00:10)

Gary Chandler (DPSOA) discussed SB 1459 relating to retirement changes authored by Senator Duncan – State Affairs.

Senator Duncan and Representative Callegari have solicited and obtained input from the Department on how these changes will affect law enforcement.

B.Legislative Update (01:18:10)

Director McCraw advised the Commission that he would have to leave the meeting at 12:30 to provide testimony at the House State Affairs hearing on driver license. Representatives Thompson and Fletcher are in support of the Schedule C raises as proposed in Item #1 of our Exceptional Items. The Senate supports the pay parity and 10% COLA; the House supports the pay parity but not the 10% COLA.

Our Subject Matter Experts (SME) are doing an exceptional job during this legislative session.

C.Trooper Activities/Officer Safety Video (1:23:30)

Director McCraw and Colonel Baker sought to find a way to explain, in a short period of time, what challenges our troopers face on a day-to-day basis for our Legislature. A video was created and has been shared with the entire DPS staff and members of the Legislature. Special thanks to Greg Moore for producing the video.

New Business (01:46:23)

A.Report by Administration and Finance Committee

Commissioner Barth provided the first report of the Administration and Finance Committee. Action items in the Committee report will be included in the PSC agenda for approval. The August PSC meeting will focus on presenting yearly contracts for approval and unforeseen needs will be presented as they occur.

Commissioner Brown recommended establishment of an Audit Committee. Audit falls under the Administration and Finance Committee and will remain there instead of establishing a sub-committee. Commissioner Brown will replace Commissioner Barth on the Regulatory and Driver License Committee.

Adjourn Into Executive Session (2:05:36)

The Commission adjourned into Executive Session to discuss security issues, to consult with legal counsel regarding pending or contemplated litigation or settlement offers or to receive legal advice on items posted on this agenda; deliberation regarding real estate matters; consideration of any other items authorized by law, including personnel matters, the Director's action of discharging employees as identified in this agenda; ongoing criminal investigations. Executive Session began at 11:08 a.m.

B.Review and discuss division of management responsibilities as required by Government Code 411.0042

General Counsel Adkins provided information on the Public Safety Commission's general duties, powers and statutory responsibilities at the request of Commissioner Watson. Chairman Leon would like to hold a work session for the PSC to review the duties. Date will be selected based upon everyone's availability.

C.Report and discussion regarding Use of Force Policy

General Counsel Adkins presented revisions made to the Use of Force Policy regarding discharging firearms at vehicles, from aircraft and from the Tactical Marine Unit.

D.Discussion and possible action regarding revision to Chief Auditor's Office Charter

Commissioner Barth requested a review of THP operations and review of Watch Guard videos in the field. Chief Auditor's Office and the Leadership & Operational Review Unit will coordinate efforts. Chairman Leon would like to focus on financial versus policy compliance.

Steve Goodson presented the CAO Charter (last reviewed/approved two years ago) adding training to advisory service.

A motion was made by Commissioner Barth seconded by Commissioner Watson approving the CAO Charter. Motion passed unanimously.

Current stats for B school:

- -110 recruits currently in firearms training
- -412 waiting for testing (written, math and physical fitness)
- -36 polygraph
- -28 oral boards
- -29 background investigations
- -Next school will begin 7/14/13
- -Fast Track new program implemented that requires you to pass testing in the field; upon passing testing, you are scheduled to come to Austin for three days to complete polygraph, assessment board, conditional job offer, medical/psychological screening and back to the field for background. This process has taken 4-6 weeks in the past and has now been

downsized to three days. We are able to process as many as 40 applicants per week thru Fast Track.

- -TDEM contracts monitoring of grant funds for federal compliance, 7 bids and 4 contracts to be issued for a total of \$25 million (no minimum, as needed contracts) over a period of $4\frac{1}{2}$ years, if needed. - Radios purchase of 337 units at cost of \$3 million
- -Cisco Telephones 6,500 phones to complete the VOIP phone system at cost of \$2.8 million
- -Fingerprint, Photo and Signature contract between Driver License and Law Enforcement Services – Commissioner Barth requested to review contract since work may be scheduled to begin prior to June PSC meeting

The Texas Department of Public Safety (the department) adopts new Sections 13.71 – 13.83, concerning Texas Prescription Program. These new sections are adopted without changes to the proposed text as published in the March 8, 2013 issue of the *Texas Register* (38 TexReg 1667) and will not be republished.

The proposed new Subchapter D is necessary to reorganize and consolidate the rules governing the Texas Prescription Program's reporting requirements and procedures and to generally improve the clarity of the related rules.

The department accepted comment on the proposed rules through April 8, 2013. Written comments were submitted by Mary Staples representing National Association of Chain Drug Stores (NACDS). Changes were made to proposed new Section 13.75 based on the comments received by the department. Substantive comments received, as well as the department's responses, thereto, are summarized below:

COMMENT: Regarding Section 13.75(3), NACDS recommends the department either eliminate the requirement to report the department's "designated placeholder" for schedule II electronic prescriptions or waive the requirement to report this particular data element until twelve months after the department provides pharmacies with the appropriate default value to report for this purpose.

RESPONSE: The department disagrees with these recommendations. The submission of the data element at issue is a requirement of the department's prescription database software application. Waiver or elimination of the requirement would cause the system to reject the electronic submission, resulting in additional administrative burdens on the dispenser and the need for manual processing by the department. In addition, no specific data element has been established at this time. It is the department's intent to establish a "placeholder" value that will have minimal or no impact on the dispenser.

This proposal is adopted pursuant to Texas Government Code, Section 411.004(3), which authorizes the Public Safety Commission to adopt rules considered necessary for carrying out the department's work and Texas Health and Safety Code, Section 481.003, which authorizes the department to adopt rules to enforce Chapter 481 of the Texas Health and Safety Code.

Written comments were submitted by Katherine Thomas, Executive Director of the Texas Board of Nursing, and by Lynda Woolbert, Regulatory Consultant for the Coalition for Nurses in Advanced Practice. Changes were made to proposed new Section 13.27 based on the comments received by the department. Substantive comments received, as well as the department's responses, thereto, are summarized below:

COMMENT: Regarding Section 13.27(e), both Ms. Thomas and Ms. Woolbert commented on certain inconsistencies between the language in this subsection and the statutory provisions of Texas Occupations Code, Section 157.054, relating to the delegation of authority to prescribe controlled substances.

RESPONSE: The department agrees with these comments and has revised the proposal accordingly, deleting text in Section 13.27(e) to remove inconsistencies with statute.

COMMENT: Regarding Section 13.27 generally, Ms. Woolbert commented on the proposal's use of the term "supervising physician" and proposed the substitution of the term "delegating physician" throughout the section to be consistent with Texas Medical Board rules.

RESPONSE: The department agrees with this recommendation and has revised the proposal accordingly.
