The Public Safety Commission met in Austin, Texas on August 31, 2018. Attending the meeting were Chairman Steven Mach, Commissioners Cynthia Leon, Manny Flores, Jason Pulliam, and Randy Watson. DPS staff members and guests were also present.

CALL TO ORDER (0:00:20)

The meeting was called to order by Chairman Mach at 10:00 a.m. Proper notice had been posted.

Robert J. Bodisch Leadership Award

Director McCraw reported on the success of the DPS Progressive Leadership Development Model program which was a vision of Director Bodisch who championed the need to increase training to ensure future agency supervisors, managers and executives were properly equipped to be successful. Over the last four years, the department instituted three leadership development courses – the Leadership Development School, Leadership College and the Command College.

Chairman Mach and the Commission agreed that Deputy Bodisch was the driving force behind the program's success and believe his contributions deserve some type of lasting recognition. An award should be presented to a member of each Command College cohort who exemplifies the same type of leadership and selfless dedication that Director Bodisch gave to this program. This will be placed as an agenda item for vote during the October meeting.

The commission acknowledged Deputy Director Bodisch's retirement and all expressed good luck and best wishes.

DIRECTORS REPORT (0:42:17)

Director McCraw started with an update on School Safety:

-Division Director John Jones briefed and demonstrated on the Governor's iWatch Texas Initiative:

- *Phone application and website versions are available
- *At time a report is filed it either goes to the state fusion or regional fusion center
- *Reports are based on location; analysts have 8 hours to vet the report, then appoint resources in the field to make contact with the student and/or parents
- *School Safety Codes will be added to the Version 2.0 update coming in October
- *Texas is the only state in the country that has statewide Suspicious Activity Reports (SAR) that report terrorism, all crimes and school SARs into one system for comparison

-DD Jones briefed and demonstrated TxMAP Tracker:

- *In-Car and Communications version that shows schools where troopers have easy, immediate access to respond to emergency situations
- *Troopers are actively collecting school information (contacts, addresses, school floor plans, etc.) to load into the system

Director McCraw proposed a change on DPS Regions:

Commission will consider proposed recommendation and will be placed on agenda for vote in October.

A. Aviation Operations (1:01:13)

Laboratory and Aviation will increase in support over the next 3 years, per Director McCraw. Aviation Operations has been in high demand and is listed as an Exceptional Item for the upcoming legislative session.

Air Support Case Update provided by Lieutenant Richard Greer and Special Agent Lance Cline:

- Notification received on 7/25/18 at the Houston air station reporting an aggravated robbery call
- Robbery of a T-Mobile store; report of stolen cash and cell phones
- Aviation was able to assist leading to the apprehension of all five suspects

Aviation video was presented to the Commission highlighting aircraft assets and expertise of the tactical flight officers.

Director McCraw followed with a Legislative Update (1:27:15)

- Veterans Affairs and Border Security hearing discussed 287G for immigration enforcement; DPS prefers to not have enforcement compliance
- Sunset Commission hearing – DPS will be around for another 12 years; two significant items:
 - *Conduct independent study to determine whether DPS Driver License function should remain with DPS or move to the Department of Motor Vehicles (DMV); should study show DL function to be moved from DPS to DMV it will occur in 4 years
 - *Transfer motorcycle and ATV safety training program to the Texas Department of Licensing and Regulation

General Counsel Adkins identified Management Recommendations made by Sunset Commission:

- No management issues for Item 1 since we are waiting for the Driver License study
- Item 2, Border Data Reporting – continue as we have been doing for border data reporting
- Item 3, Private Security Bureau – issues are statutory; Bureau hears final licensing Actions on hundreds of cases per year that could significantly impact the burden and Workload of the Public Safety Commission
- Item 7, Contracting and Purchasing – we agree with the recommendations and continue with our current levels of review, approval and accountability

Chairman Mach commented it is our preference that Driver License remain under DPS and we will continue to move forward until a decision is made.

Commissioner Leon asked Amy Clay (Government Relation) to give the Commission a significant heads up on all upcoming hearings involving DPS during the legislative session.

B. Report, discussion, and possible action regarding the FY2019 Internal Audit Strategy proposed by the Chief Auditor's Office (2:16:33)

Brief provided by Chief Auditor Catherine Melvin:

-Not proposing any changes to their strategy at this time.

A motion was made by Commissioner Pulliam, seconded by Commissioner Flores, to approve New Business Item B for approval of the FY2019 Internal Audit Strategy. Motion passed unanimously.

C. Report, discussion on Driver License Update (2:20:56)

Brief provided by DD Amanda Arriaga and Chief Auditor Catherine Melvin:

Why do Driver License lines continue to get longer:

-We do not have enough Customer Service Representatives (CSRs) to fully staff every office

-Population continues to increase. New residents to Texas must conduct their transactions in a DL office.

-Number of people who do not need to come into a DL office but choose to do so anyway, continues to increase:

*FY17 – 52%

*FY16 – 43%

*FY15 – 29%

*FY14 – 16%

Office Closures:

-Sunset recommendation to close inefficient DL offices

-Intermittent office closures (continue to happen) – closed due to safety and other operational issues and CSR is sick or on vacation

Mandatory In Office Transactions Only:

-Implemented in Conroe, Denton, Grand Prairie, Houston-Dacoma, Plano, Rockwall and Temple

-Since 7/9/18, these offices are only accepting customers who must conduct their transaction within an office for Original, Renewal after 12th Year, Over 79 and Under 18)

-Customers with transactions that can be handled online, by phone or by mail are redirected to these options, or provided directions to the closest full service office

-During first 6 weeks, renewal and duplicate transactions in those offices decreased on average by 32%. Surrounding offices had an increase of 5%.

In Person Eligibility Review:

-8/9/18, in 41 additional offices, new initiative began for THP Troopers to discuss with

- customers their ability to determine if they could conduct their transactions alternatively
- Customers asked if they have checked their eligibility on Texas.gov or by calling 1-866-DL-RENEW
 - Customers able to renew alternatively are asked if they would like to get out of line and conduct transaction alternatively
 - Customers provided hard copy of the mail in renewal form, providing them a third alternative to renew

Ongoing Marketing Efforts:

- Continue education in form of tweets and press releases
- Make Waiting In Line a SNAP – video
- Working with Deloitte/Texas.gov on marketing survey to determine why customers come into the offices rather than using Texas.gov
- Working with TxDOT to expand our reach through their social media and determining what additional TxDOT marketing channels may be appropriate

Proposed Improvements for Future (Exceptional Items Request):

- Reclassify Customer Service Representatives to License & Permit Specialists; increasing their salary from \$26K to \$35K per year
- Fully staff all DL offices
 - *At current level off offices, this is 854 additional FTEs
- Add 15 additional offices in most populated Metropolitan Statistical Areas and fully staff

Chief Auditor Melvin was asked in 2016 by then-Driver License Division Director Joe Peters to perform a rigorous examination of all Driver License Improvement Plan (DLIP) funds appropriated to the agency since inception in FY2012. As part of the review, they worked with our Finance Division and were able to identify all indexes related to DLIP budget and expenditures. They were able to reconcile the Department's DLIP budget and expenditures to DLIP appropriations for all three biennium as of the date of their issued memo in FY16.

Chairman Mach inquired if they were aware of any other DLIP funding audit work being conducted. Melvin stated the State Auditor's Office is currently conducting an audit of the Driver License Division. Their scope includes three areas – issuance of driver licenses and identification cards, controls over the Driver License System, and compliance of financial transactions, which includes Driver License Improvement Plan funds.

Proposed Improvements for the Future:

- Legislative Changes:
 - *Extend the term of the DL from 6 to 8 years

- *Extend the term of the CDL from 5 to 8 years
- *Waive Driving Test for persons under 18 who have completed Driver Education
- *Provide the ability to submit a new photograph electronically
- *Remove the need for the audit number on the DL to conduct transaction online
- *Consider appointment only model
- *Consider co-location of agency services

- B-2018 Class has completed Week 13, 96 applicants – scheduled to graduate November 30, 2018
- Processing over 3,900 applications for the A-2019 class, 270 are in background Process, school scheduled to start January 27, 2019
- Advanced Law Enforcement Rapid Response Training (ALERT) Program – THP and CID are providing training for first responders responding to an active shooter event

Driver License Rules
Title 37 T.A.C. Part I, Chapter 15
Subchapter B
Section 15.34

The Texas Department of Public Safety (the department) adopts the repeal of §15.34, concerning Renewal Period Prior to Expiration. This repeal is adopted without changes to the proposed text as published in the July 27, 2018 issue of the *Texas Register* (43 TexReg 4959) and will not be republished.

The repeal of this rule was filed simultaneously with proposed new §15.34 and is necessary to inform the public of changes to the time period for renewal prior to expiration.

No comments were received regarding the adoption of this repeal.

This repeal is adopted pursuant to Texas Government Code, §411.004(3), which authorizes the Public Safety Commission to adopt rules considered necessary for carrying out the department's work; and Texas Transportation Code, §521.005, which authorizes the department to adopt rules necessary to administer Chapter 521 of the Texas Transportation Code.

The Texas Department of Public Safety (the department) adopts new §15.34, concerning Renewal Period Prior to Expiration. This rule is adopted without changes to the proposed text as published in the July 27, 2018 issue of the *Texas Register* (43 TexReg 4960) and will not be republished.

This new rule is intended to provide greater customer convenience and flexibility by expanding the renewal period prior to expiration of most driver licenses (DL) or identification cards (ID) from one year to two years.

No comments were received regarding the adoption of this rule.

This rule is adopted pursuant to Texas Government Code, §411.004(3), which authorizes the Public Safety Commission to adopt rules considered necessary for carrying out the department's work; and Texas Transportation Code, §521.005, which authorizes the department to adopt rules necessary to administer Chapter 521 of the Texas Transportation Code.

This agency hereby certifies that the adoption has been reviewed by legal counsel and found to be a valid exercise of the agency's legal authority.

The effective date of the rules is 20 days after the rules are filed with the Texas Register Division, Office of the Secretary of State.

The Texas Department of Public Safety (the department) adopts amendments to §15.59, concerning Alternative Methods for Driver License Transactions. This rule is adopted without changes to the proposed text as published in the July 27, 2018 issue of the *Texas Register* (43 TexReg 4961) and will not be republished.

The amendments are intended to provide greater customer convenience by allowing commercial driver license (CDL) holders to obtain duplicates and change of address by alternative methods.

No comments were received regarding the adoption of this rule.

This rule is adopted pursuant to Texas Government Code, §411.004(3), which authorizes the Public Safety Commission to adopt rules considered necessary for carrying out the department's work; Texas Transportation Code, §521.005 and §522.005, which authorizes the department to adopt rules necessary to administer Chapter 521 and Chapter 522 of the Texas Transportation Code; and Texas Transportation Code, §§521.054, 521.146, and 522.032.
