PUBLIC SAFETY COMMISSION MEETING MINUTES – September 27, 2011 Austin, TX

The Public Safety Commission met in Austin, Texas on September 27, 2011. Attending the meeting were Chairman Allan Polunsky, Commissioners Ada Brown, Carin Barth, and Cindy Leon. Commissioner John Steen was absent. A quorum was present for the meeting. DPS staff members and guests were also present.

Call to order

The meeting was called to order by Chairman Polunsky at 10:03 a.m. Proper notice had been posted.

Approval of Minutes (01:09 - indicates time stamp from audio file)

A motion was made by Commissioner Leon seconded by Commissioner Barth approving the minutes as submitted for the August 25, 2011 meeting. Motion passed unanimously.

Public Comment (01:41)

There were no public comments.

Director's Report (02:00)

Director Steven McCraw provided an extensive report on the border security strategic assessment that had been done by General Barry McCaffrey (ret.) and Retired Major-General Robert Scales during the 82nd Session of the Legislature. The report highlighted the efforts that Texas has put in place in order to combat the threat from the Mexican cartels and commended Texas for being "the most aggressive and creative in confronting the threat."

The report further determined that criminality spawned in Mexico is spilling over to the U. S. and Texas is the tactical close combat zone and frontline of this conflict.

The Commission discussed the impact criminal aliens were having on communities in Texas. Director McCraw stated that criminal aliens were responsible for a significant amount of crime and constituted a serious threat.

As of September 15, 2011, 6,508 illegal aliens have been identified in Texas Department of Criminal Justice units. These 6,508 criminal aliens are responsible for 27,880 total crimes over their criminal careers.

From October 2008 through August 2011, Texas has identified a total of 88,080 unique criminal alien defendants in Texas. These defendants are responsible for 344,398 individual criminal charges over their criminal careers, including 2,245 homicides and 46,412 sexual assaults. Director McCraw provided a detailed breakdown of the violations committed by the 88,080 criminal aliens. (His presentation slides are a part of these minutes). Director McCraw said since 2007, Texas provided over 2.1 million hours of overtime to increase local and state law enforcement boots on the ground. He credited the efforts of former Commander Heam and Commander Rodriguez.

Commissioner Brown recounted that when she served as a prosecutor, she had numerous cases in which illegal aliens were convicted of serious crimes and were later released by the federal government. Commissioner Brown requested future updates.

Chairman Polunsky questioned the federal government's use of the catch and release policy. Director McCraw insured the Commission he would provide updates ongoing.

New Business:

(59:30) Purple Heart Presentation to Daniel Shown. Director McCraw presented a Purple Heart, which recognizes bravery and selflessness, to Trooper Daniel Shown. Trooper Shown was shot while responding to a disturbance call in December 1988. Trooper Shown was struck in the forehead, resulting in the loss of his right eye and permanent paralysis of the left side of his body. He was joined at the Commission presentation by his family and close friends. Director McCraw said Trooper Shown was and would always be a hero and member of the DPS family. The Commission thanked Trooper Shown and his family for their sacrifice.

(01:10:04) <u>Discharge Appeal Hearing and possible action regarding DPS employee Joseph</u>
<u>Cormier.</u> A motion was made by Commissioner Brown seconded by Commissioner Leon affirming the director's decision to discharge Joseph Cormier. Motion passed unanimously.

Adjourn into Executive Session

The Commission adjourned into Executive Session to discuss security issues, to consult with legal counsel regarding pending or contemplated litigation or settlement offers or to receive legal advice on items posted on this agenda; deliberation regarding real estate matters; consideration of any other items authorized by law, including personnel matters, the Director's action of discharging employees as identified in this agenda; and ongoing criminal investigations. Executive Session began at 1:35 p.m.

The Public Safety Commission reconvened at 2:37 p.m. A quorum was present.

Report, discussion and possible action on Department Veteran Assistance Program (DVAP). This program was developed to assist the Department employees throughout the predeployment, deployment and post-deployment cycle; concentrating on the employee, the employee's family and the Department. Captain David Franklin and Dr. Frances Douglas, DPS Staff Psychologist reported on the DVAP mission objectives; challenges for the program design and implementation; the components; partners, procedure and information. Chairman Polunsky asked that Commissioner Leon serve as the Liaison to this group. The slides that were presented with details on this program are a part of these minutes. Chairman thanked Captain Franklin for his service to this country and thanked both he and Dr. Douglas for their efforts in the program.

Report, discussion, and possible action on proposed amendments to Driver License Rule for publication: Rule 15.24, 37 TAC Sec. 15.24 concerning Identification of Applicants and Report, discussion, and possible action on proposed repeal of Driver License Rule for publication: Rule 15.171, 37 TAC Sec. 15.171 concerning Issuance of Driver Licenses and Identification Certificates to Non-citizens. AD Rebecca Davio reported on these two related

rules with respect to lawful presence/temporary visitor stating the new license would reflect Limited Term. AD Davio stated the two rules were being presented for approval to post in the Texas Register. She added an applicant will no longer be required to demonstrate they have at least six months validity remaining on their lawful presence document or that the document was issued for at least a year. She said Temporary Visitor will no longer be indicated on the face of the card. She displayed an example of the appearance of the Limited Term Card. A motion was made by Commission Leon seconded by Commissioner Barth approving both rules for posting. Motion passed unanimously.

Report, discussion and possible action on proposed new Driver License Rules for publication: Rules 15.181 – 15.185, 37 TAC Secs. 15.181 – 15.185 concerning Election Identification Certificate. AD Davis stated this rule was the result of Senate Bill 14 being implemented which addressed Election Identification Certificates (EIC). This rule was also presented for approval to post in the Texas Register. The Election Identification Certificate will be issued to anyone who is eligible to register to vote, but does not have a driver's license. There will not be a fee charged for this certificate and the applicant must have already applied to register to vote, or submit one at the time of applying for an EIC. She displayed an example of the appearance of the EIC. A motion was made by Commissioner Brown seconded by Commissioner Leon approving the rule for posting. Motion passed unanimously.

Chairman went to Reports and AD Davio continued with an update of the Driver License Division transformation. She stated L1 met their service level agreement of 3 day card delivery last month and they had been very responsive in the need for quick turnaround of the Limited Term Card and Election Identification Certificate design.

AD Davio provided the current status of online scheduling and said individuals could now schedule up to 90 days out at the N. Lamar office in Austin. She said they hoped to roll out online scheduling very soon at all locations.

AD Davio reported the status on the mega centers, adding that five of the six mega center locations had signed leases. Austin had not yet been finalized, but was identified and negotiations had begun. The target date for all leases to be signed was October 19, 2011. Commissioner Barth inquired about the specific locations and what the actual bill specified with this regards. AD Davio stated 82nd Legislature HB 1 language did not state specific locations rather to "establish six new mega centers and provide furniture/equipment for those mega centers..." with locations in: Dallas-Ft. Worth, San Antonio, Austin and Houston. Commissioner Barth asked how much money had been provided for the locations. AD Davio stated \$3.3 million had been allotted for the biennium towards rent for these centers, all with 10 year leases. Commissioner Barth was concerned about the Houston locations, specifically Rosenberg. AD Davio explained the analysis and recommendations provided by Texas State University used to define optimal locations for the mega centers and vetted both locally and statewide within the Department. This study and the location checklist criteria were provided to the Texas Facility Commission for location bids and TFC negotiated final leases. Commissioner Barth explained her struggle again with the Rosenberg location stating this was twenty miles away from Houston 610 loop/downtown. AD Davio said there were eleven offices currently in Harris County. Houston. AD Davio presented slides showing the locations with shaded areas that identified the most densely populated areas and stated she felt good about the site identified. AD Davio did say they only received one bid for this area, none were found in Katy where a previous lease had been terminated. Commissioner Barth stated she felt Rosenberg was a mistake and inquired how we could go back and correct since this was not the city of Houston, and it needed

to be closer. Chairman Polunsky stated this should have been brought to the Public Safety Commission. AD Davio stated they were trying to meet the very aggressive lease signing target date. Director McCraw said it had been an oversight on his part. Commissioner Barth stressed she was disappointed with TFC to provide the one spot. AD Davio reported that driver license offices are very difficult to locate due to the constraints of needing a large amount of parking, a residential area to conduct driving tests and to be near major thoroughfares. Chairman Polunsky requested that AD Davio keep him in the loop of what was done.

(05:00:22) Report, discussion and possible action on update from General Counsel's office of contract management and legal expertise charged with oversight of contracts. General Counsel Phillip Adkins reported on the process of this oversight detailing the types of contracts and the current process for contract development and administration. He added that the Procurement & Contract Services Director and team had expertise in contracts and negotiations. GC Adkins outlined the proposed goals, communication, criteria, teams, and monitoring of the process. He added that this oversight would be divided among five attorneys who have other ongoing duties. but no full time contracting attorneys. He reported on what it would take to implement, the current status of the process, and displayed a slide showing the new review process. AD Brown, Administration joined in the discussion reporting on the contract review board process stressing the procurement process was largely manual and an automated, integrated procurement system would be purchased. They are at the stage of working with the potential vendor to determine the cost of the system and agency resources necessary to maintain the system. This is expected to take approximately one year to implement after final Comptroller approval and project award. Chairman Polunsky stated he would like to aggressively go forward with the process proposed. GC Adkins stated at minimum they would need a lawyer and legal assistant. Chairman agreed on at least two of the FTE's. A motion was made by Commissioner Barth seconded by Commissioner Brown approving the funds to move forward as stated. Motion passed unanimously.

Review of pending TXMAS contract awards:

- a. <u>Audit Services for the Texas Division of Emergency Management (Grant Thornton LLP)</u>
- b. <u>Audit Services for the Texas Division of Emergency Management (Horne LLP)</u>
 AD Brown, Administration provided status on this information only item. She stated these pending contracts would go through the usual process and Commissioner Barth would provide the approval after the CRB completed their process.

Report, discussion and possible action regarding proposed FY 2012 Chief Auditor's Office Plan AD Goodson provided information for consideration and action on this risk based audit plan required by the Texas Internal Auditing Act and professional audit standards. A motion was made by Commissioner Barth seconded by Commissioner Leon approving the plan. Motion passed unanimously. AD Goodson continued reporting on the status of the seven issued reports since the last PSC meeting. He stated three of those reports would be provided in October. There was no action required.

Report, discussion and possible action regarding the appointment, promotion, employment, evaluation, reassignment, duties, discipline, or dismissal of a member of the Department or Commission management team

Director McCraw requested the advice and consent of the Public Safety Commission for Carey Matthews to become Regional Commander of Region 4; for Luis Gonzalez to become the AD of THP; Gary Albus to become the Regional Commander of Region 6 and Duane Steen to

become the Regional Commander of Region 2. A motion was made by Commissioner Brown seconded by Commissioner Barth approving the promotions as indicated by Director McCraw. Motion passed unanimously. Chairman congratulated all on their promotions.

Report, discussion and possible action by the Commission regarding modification and transformation of the DPS organizational structure approval of personnel placements and salaries pursuant to Government Code chapter 411, Secs. 411.005, 411.005 and 411.0071 No discussion

<u>Update report, discussion and possible action regarding the status of building safety and security at the DPS campus on North Lamar</u>
This item was updated in Executive Session.

Status Report and discussion regarding HB 2131 the development of rules for eligibility, application, approval, issuance, and renewal for a Capitol Access Card AD RenEarl Bowie stated there were no updates at this time.

Ongoing Business

Report, discussion and possible action on the Fiscal Year 2011 Operating Budget AD Denise Hudson, Finance reported a balance for FY11 of \$803,842. She added that the current vacancies for commissioned employees totaled 368.

Chairman Polunsky stepped out of the room. Commissioner Barth chaired in his brief absence.

Report, discussion and possible action regarding purchases using seized funds No requests were pending approval.

Deputy Director Cheryl MacBride, Services stated she wanted to recognize all in the Finance team involved in the migration of the MSA (Management Science of America) system, which had been no easy task. This system conversion impacted all financial processes of DPS and management's goal is to minimize the transition for all of Finance staff to adjust back to optimal capacity.

<u>Update report, discussion and possible action regarding recruitment</u>

DAD Woodall stated the current school began with 75, 13 resigned to date, resulting in 62 current recruits. They are in week six of the academy.

DAD Woodall added since June 2001, 2918 applications have been submitted online. He provided the status of their various stages in the process. Commissioner Leon asked if the same 74 would be the quantity to start the next school, DAD Woodall confirmed. Chairman Polunsky inquired about the schedule. DAD Woodall said currently there was not a schedule; first they had to qualify those candidates since at present they only had 14. He stated that graduation is scheduled for Thursday, January 19, 2012.

Report, discussion and possible action regarding Continuity Plan at the Department of Public Safety

No further discussion outside of Executive Session report.

Follow-up report, discussion and possible action regarding creation of a foundation to benefit the Texas Department of Public Safety

Chairman Polunsky asked GC Adkins to provide a brief update on the foundation status. GC Adkins stated it was decided to move forward in establishing a new foundation connected to the department. It was proposed to be called the Texas Department of Public Safety Foundation. Chairman expanded on the current foundation and added they were at the point it was prudent to form the new foundation immediately, and he felt a lot of good things would be coming out of it. He added any action necessary to take towards the other foundation would be addressed

Follow-up report, discussion and possible action on the Department of Public Safety ethics policy and reporting requirements

This item will be deferred to the November meeting due to Commissioner Steen's interest and his not being present.

Status report, discussion and possible action on TxDOT median dividers and effectiveness in deterring vehicles crossing over and law enforcement turn around areas.

AD Gonzalez reported that 76 out of 241 of the cross-over's are completed. San Antonio had six requests and one of those was started. Deputy Director Baker added that TxDOT was fully supportive.

Report, discussion, and possible action regarding the adoption of proposed amendments to Texas Highway Patrol Rules: Rule 3.22, 37 TAC Sec. 3.22 concerning Written Warning AD Gonzalez stated they were seeking final adoption for this rule that involved child restraints, seat belt. A motion was made by Commissioner Brown seconded by Commissioner Leon approving the adoption. Motion passed unanimously.

<u>Status report, discussion and possible action on Department generators – specifically conversation updates with electrical companies around the state</u>
No further discussion.

Chief Kidd thanked everyone involved in the Department during the recent wildfires. Chairman thanked Chief and his division who worked collaboratively with the Department in the positive moment during a negative situation.

AD Doggett displayed his new dashboard reporting format slides for the key areas of IT operations. He stated the call centers had greatly improved responses. He said there were message and wait queues which helped in resolving the calls.

Chairman asked the new AD Law Enforcement Support to step up and express how things were going. AD Hearn, Law Enforcement Support stated he currently would be learning a couple of new languages and learning the aspect of the business. Commissioner Leon stated that during the time she recently spent with AD Hearn she was very impressed.

Discussion and possible action on the proposed repeal to Crime Records Rule for publication:

Rule 27.31, 37 TAC Sec. 27.31, concerning Registration of Tattoo Marks

AD Hearn requested Commission approval on the proposed repeal of this rule. A motion was made by Commissioner Barth seconded by Commissioner Brown to approve the repeal for publication. Motion passed unanimously.

There were no further division reports.





TEXAS DEPARTMENT OF PUBLIC SAFETY ORDER ADOPTING A RULE

On September 27, 2011, the Public Safety Commission (the commission) by majority vote approved rules concerning:

Texas Highway Patrol
Title 37 T.A.C. Part I, Chapter 3
Subchapter B
Section 3.22

The Texas Department of Public Safety (the department) adopts amendments to Section 3.22, concerning Written Warning. This section is adopted without changes to the proposed text as published in the August 12, 2011 issue of the *Texas Register* (36 TexReg 5079) and will not be republished.

Amendments to Section 3.22 are necessary to update the rule so that it reflects the department's revised enforcement policy. The revision updates certain terminology and allows written warnings to be issued for occupant restraint violations. Written warnings may be appropriate in those instances when two individuals may be charged for a single violation or when multiple violations occur in a single traffic stop and issuing multiple citations to a single family could create an economic hardship rather than achieve voluntary compliance with the Transportation Code.

No comments were received regarding the adoption of these amendments.

The amendments are adopted pursuant to Texas Government Code, Section 411.004(3), which authorizes the Public Safety Commission to adopt rules considered necessary for carrying out the department's work.

This agency hereby certifies that the adoption has been reviewed by legal counsel and found to be a valid exercise of the agency's legal authority.

The effective date of the rules is 20 days after the rules are filed with the Texas Register Division, Office of the Secretary of State.

This order constitutes the order of the commission required by the Administrative Procedures Act, Government Code, Section 2001.033.
